### NJGPA Overview (1 of 2)

- The State graduation proficiency test [NJGPA] shall be administered to all 11th grade pupils and to any 11th or 12th grade pupil who has previously failed to demonstrate mastery of State graduation proficiency standards on said test. (N.J.S.A. 18A:7C-6)
- NJGPA is designed to measure the extent to which students are graduation ready in English Language Arts (ELA) and Mathematics.
- Graduation readiness is reported separately for each content component.
- The ELA component is aligned to the grade 10 standards.
- The Mathematics component is aligned to Algebra I and Geometry standards.

## NJGPA Overview (2 of 2)

- Students who take but do not meet the minimum required score (725) on each component of the assessment will have the opportunity to receive additional supports and may take the following steps:
  - Retake the ELA and/or mathematics components of the New Jersey Graduation Proficiency Assessment in the following summer or fall;
  - Meet a designated cut score from the menu of substitute competency tests; or
  - Complete a portfolio appeal.

### **Alternate Pathways**




- Students had the opportunity to retake necessary components of the NJGPA last week. Scores are forthcoming.
- Those who still do not achieve the cut score may take the Accuplacer, PSAT, SAT, or ACT, and as long as they demonstrate proficiency, they are eligible to graduate.
- Others may go through the portfolio appeals process.

#### Graduation Ready Percentage






## Subgroup Charts – Program - ELA



#### **Graduation Ready Percentage**






### Subgroup Charts – Ethnicity/Race - Math



#### Graduation Ready Percentage



## Notable Achievements

- •Overall achievement in ELA and Math have grown by 2.5 and 9.2 percentage points respectively.
  - •This growth is driven by dramatic leaps in performance of our ethnically diverse subgroups, our economically disadvantaged students, and our students with 504 plans.
- •These improvements reflect the impact of targeted intervention strategies and support systems, particularly for historically underperforming groups.
- •The data highlights Hopatcong's progress in closing achievement gaps and preparing more students for graduation success.



## Intervention Strategies

- •Continue to utilize standardized and benchmark data to **personalize instruction**:
  - Juniors will now take the Linkit NJGPA released items benchmarks for ELA and Math
    - Data will be used to identify Tier 2 and Tier 3 students who need additional support in areas of need
    - Algebra Readiness and Algebra Aptitude Screeners will also be utilized in the lower grades to ensure standards mastery.
- •Intervene earlier and more often
  - •RISE (Review, Intervene, Support, Enrich) period will be piloted for 8th graders this year to provide teachers and students with further time to master key concepts and skills that are requisite to success in later grades and on the NJGPA/NJSLA
- •Continue efforts to battle chronic absenteeism
- •HHS administrative reorganization
  - •Principal of Academic Affairs will lead **student data teams** to oversee and streamline the RTI process for students
